SUMMARY OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA MESA AMENDING TITLE 24 OF THE LA MESA MUNICIPAL CODE TO ESTABLISH PROVISIONS FOR EMERGENCY SHELTERS AS REQUIRED BY STATE LAW

Pursuant to Government Code Section 36933 (c), the following constitutes a summary of an Ordinance introduced by the La Mesa City Council on Tuesday, January 22, 2019, and scheduled for consideration of adoption on Tuesday, February 12 at 6:00 p.m., at its regularly scheduled meeting to be held in the La Mesa City Council Chambers, 8130 Allison Avenue, La Mesa, California:

This Ordinance would amend Title 24 – Zoning of the La Mesa Municipal Code by amending Section 24.04.05 – Off-street parking required and Section 24.06.020 – Permitted structures. The Ordinance amends Title 24 – Zoning by allowing for emergency shelters as a permitted use in the General Commercial (C) and Neighborhood Commercial (CN) zones. The Ordinance establishes off-street parking requirements and provisions, regulations, and requirements for the establishment and continuance of use for emergency shelters within the City of La Mesa. In summary, this Ordinance amends Title 24 – Zoning of the La Mesa Municipal Code to allow emergency shelter uses and to establish provisions for emergency shelters as required by California Government Code Section 65583 and as set forth in the Housing Element of the City of La Mesa General Plan.

A certified copy of the full text of the Ordinance is posted and available for review in the Lobby of City Hall and the City Clerk's Office at 8130 Allison Avenue, La Mesa California during normal business hours.

If adopted, this Ordinance shall be effective 30 days after its adoption and the City Clerk of the City of La Mesa is hereby authorized to use summary publication procedures pursuant to Government Code Section 36933 utilizing the East County Californian, a newspaper of general circulation published in the City of La Mesa.
