No more than 20% of the CDBG allocation may be expended on program administration. Approximately \$350,000 of 2019-20 CDBG and \$20,000 of prior year resources are anticipated to be available for housing and community develop-ment projects for FY 2019-20. Anticipated future program income of approximately \$15,000 from repayment of previous loans through a currently suspended Housing Rehabilitation Loan Pro-gram will be committed to loan portfolio administration. No other program income is generated as a result of CDBG allocations made by the City.

For FY 2019-20, the City will continue to participate in the HOME Program through membership in the San Diego County HOME Consortium. The HOME Program supports a Down Payment and Closing Cost Assistance (DCCA) program for first time home buyers.

ORDINANCE 19-01 OF THE BOARD OF DIRECTORS OF HELIX WATER DISTRICT INCREASING COMPENSATION OF DIRECTORS, EFFECTIVE APRIL 15, 2019, AND SUPERSEDING ORDINANCE 03-01 **ADOPTED JUNE 18, 2003**

BE IT ORDAINED by the Helix Water District Board of Directors as follows:

Section 1. That directors of Helix Water District shall be compensated as follows:

- a) That each director shall receive compensation in the amount of \$225 for each day's attendance at meetings of the board and of committees established by the board.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA MESA AMENDING TITLE 24 OF THE LA MESA MUNICIPAL CODE TO ES-TABLISH PROVISIONS FOR EMERGENCY SHELTERS AS REQUIRED BY STATE LAW

Pursuant to Government Code Section 36933 (c), the following constitutes a summary of an Ordinance introduced by the La Mesa City Council on Tuesday, January 22, 2019, and thereafter adopted on Tuesday, February 12, 2019.
This Ordinance would amend Title 24 – Zoning of

the La Mesa Municipal Code by amending Section 24.04.05 – Off-street parking required and Section 24.06.020 – Permitted structures. The Ordinance amends Title 24 – Zoning by allowing for emergency shelters as a permitted use in the General Commercial (C) and Neighborhood Commercial (CN) zones. The Ordinance establishes off-street parking requirements and provisions, regulations, and requirements for the establishment and continuance of use for emergency shelters within the City of La Mesa. In summary, this Ordinance amends Title 24 – Zoning of the La Mesa Municipal Code to allow emergency shelter uses and to establish provisions for emergency shelters as required by California Government Code Section 65583 and as set forth in the Housing Element of the City of La Mesa General Plan
