

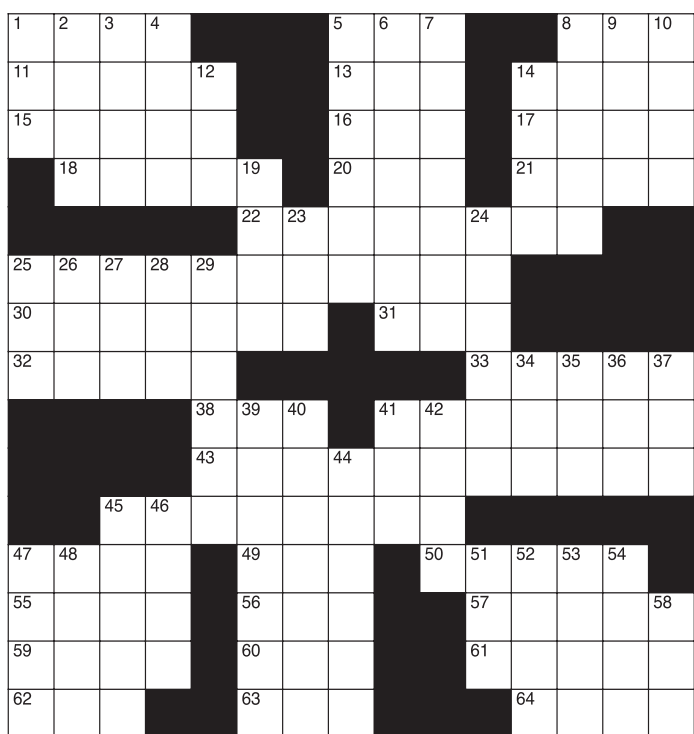

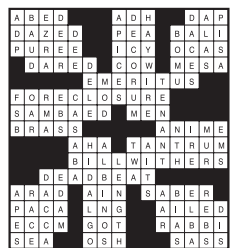

GEMINI LIGHT BEAMS, RULE OF LAW & THE LANGUAGE OF THE HEART

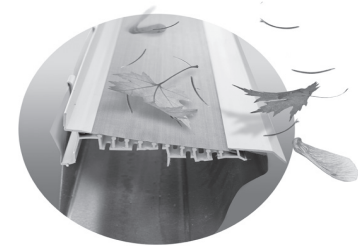
